Specific Terms and Conditions:

1. The approved Projects mentioned in this Order should be implemented through the Executive Agencies as per the approved Rules, Procedures and the Guidelines issued vide P&C Department letter no. 11449 (30) dt. 30.09.2021 and letter no. 8160 (30) dt. 02.05.2023.

(i) A Micro Plan shall be prepared in consultation with all stakeholders for various components to be taken up in respective Institutions. Focus in educational institutes should be on priority items like Smart classrooms, e-libraries, Toilets, Drinking water, Science laboratories.

(ii) The District Level Apex Committee headed by Collector shall decide the modalities of execution in the interest of early completion and quality. To the extent possible, there should not be dislocations which will hamper the academic activities on the campus.

(iii) This work will be done under the supervision of the all stakeholders to ensure timely completion of work.

(iv) Upon completion of the work, the maintenance of the asset will be entrusted with the management committee.

2. The Grants-in-Aid is subject to the following terms and conditions.

i. The concerned Collector-cum-CEO should ensure that funds are not released/ utilised for repair/ construction by way of renovation, restoration or repair of religious institutions constructed

ii. The CDO-cum-Executive Officer, Zilla Parishad will be the Grantee and the Collector-cum-CEO of the District will be the Countersigning Officer in respect of the Grant-in-Aid released herein.

iii. The Monthly expenditure statement should be sent to this Department by the 1st week of the month following the month to which the statement relates.

iv. The QPR/MPR indicating physical and financial achievement should be furnished to this Department punctually.

v. The amount now sanctioned shall be spent during the current financial year 2023-24.

vi. The accounts shall remain open for audit both by the Account General Odisha as well as the internal audit of the P&C Deptt.

vii. The asset register should be created and assets so created out of the Grant-in-Aid should not be disposed of without approval of Government.

viii. They are further requested to strictly adhere to F.D. Circular No.- 10367/F dt. 31.03.2023 while sanctioning Special Problem Fund renamed as (CM-Special Assistance (Mukhyamantri Swatantra Sahayata) to concerned executing agencies.

3. The Collectors-cum-CEO of the District is responsible for timely implementation of Work/ Project. The detailed report regarding utilization of funds released under the scheme along with accumulated unspent balance available in the Zilla Parishad & Status of submission of Utilization Certificate should be sent to this Department early.

4. Utilization Certificate in respect of the sanctioned amount should be furnished by the concerned CDO-cum-Executive Officer, Zilla Parishad, after due countersignature of the Collector through the District Planning & Monitoring Unit in duplicate.

5. The Utilization Certificates should be furnished by the implementing District to concerned Zilla Parishad / DPMU in the format prescribed by Finance Department.

6. Further, the CDO-cum-Executive Officer of the concerned Zilla Parishad is requested to follow the stipulation of Finance Department before release of funds to the executing agencies.




