Sub:- Construction of Composite Urban Modern Hostel .

Ref:- Letter No- 3096 dt 21.02.2023 & No-8764 dt 6.05.2023 of SSD.

Sir,

In order to encourage higher enrolment, retention and reduction of dropout rate in educational institutions, the State Govt. have taken up the flagship programme of establishment of hostels for ST/ SC Girls and Boys from time to time. Besides, hostels are being constructed for OBC and Minority students to provide residential facilities. Similarly Govt. have also decided to construct 114 nos. of Composite Urban Modern Hostels in Urban areas of the State to facilitate higher and job orientated studies for all category of students (i.e. ST/ SC/ OBC/ Minority). Accordingly, Govt. have already sanctioned 86 nos. of 100 seated Composite Urban Modern Hostel to different districts. Meanwhile, Govt. have again been pleased to sanction 13 nos more of 100 seated Composite Urban Modern Hostels to three districts including that of yours, as per the list enclosed at ANNEXURE -I .

Plan and Design

A standard plan and design for 100 seated Composite Modern Urban Hostels has been developed by the ST/ SC Development Department and shared with all the districts earlier vide Letter No- 5066 dt 14.03.2023. You may suitably modify the plan depending on the availability of area in the identified sites and keeping the existing infrastructure of the identified institutions in view.

Location

In case of change of location of a hostel on account of logistic difficulties or other difficulty situation, District Level Committee (DLC) will take final decision under intimation to this Department.

Provision of funds

The expenditure for Composite Urban Modern Hostel will be met out of the State Sector Scheme.

Executing Agency

ITDAs shall be the Executing Agencies for construction of Composite Modern Urban Hostel in TSP areas and BDOs shall be the executing agencies for non-TSP area. In non-TSP areas, allotment will be placed with DWOs and subsequently disbursed to concerned BDOs on approval of Collectors. On completion of the building the same shall be handed over to the head of the institutions by the executing agencies under intimation to the DWOs.

The handing over / taken over report shall be signed by the head of the institutions, the A.E. concerned of the ITDA (in TSP areas) / Block (in non-TSP areas) and the executants in cases of hostels constructed within premises of institutions.

Similarly, in case of hostels constructed in standalone places, the handing over / taken over report shall be signed by the DWO / A.E. concerned of ITDA (in TSP area) / Block (in non-TSP area) and the executants. One copy of the handing over / taken over report shall be kept by the DWO for this office purpose and one copy of the same shall be forwarded by DWO to the Department for office record.

However, subsequently it has been instructed that Collectors of the districts are at liberty to decide and select other executing agencies of the State Government at their level in Non- TSP area for execution and timely completion of such projects, under intimation to the Department .

Monitoring by Collectors/ ST & SC Dev. Deptt.

Govt. in ST & SC Dev. Deptt. will monitor construction of these hostels from time to time. A monthly progress report in the prescribed format (Annexure-II) shall be submitted by the concerned executing agencies to Govt. in ST & SC Dev. Deptt. by the end of every month.
